Case Study

Leukaemia & Blood Cancer **New Zealand**

Leukaemia & Blood Cancer New Zealand (LBC) is the national charity dedicated to supporting patients and their families living with blood cancers (leukaemia, lymphoma, myeloma, and serious blood conditions).

LBC has been supporting New Zealanders affected by blood cancers since 1977. LBC's work is only possible through fundraising events and the generous support they receive from individuals, companies, trusts, and grants. AGT has supported LBC since 2005. LBC works closely with the AGT grants team to develop applications for grants for their operational costs such as the Support Services Team salaries. Anna Deason, Grants Manager at LBC NZ says "We are very grateful for the ongoing financial support we have received from AGT. This ensures our Support Services Team are out on the road throughout the country, dedicated to improving the lives of those impacted by blood cancer. From organising counselling for children, or by lending a listening ear, the team are at the heart of LBC's mission to care."

The ongoing partnership with AGT stands as a testament to the resilience and commitment of both organisations. This support enables the organisation to extend its reach, provide essential services, and make a meaningful impact in the lives of individuals navigating the challenges of blood cancers throughout New Zealand.



CHAIR AND CHIEF EXECUTIVE'S REPORT

On reflection, 2023 work streams continued to be impacted by the ongoing uncertainty surrounding the regulatory changes. The Judicial Review wasn't delivered until 21 December 2023 and the end result was no change to the regulations. AGT will continue to provide support and education tools to our venue operators to ensure they have all the information and assistance necessary to run compliant venues and socially responsible gaming operations.

Despite the circumstances, we are pleased to report that Aotearoa Gaming Trust (AGT) has increased our harm minimisation efforts and continued to work on community relationships in order to meet our strategic social responsibility goals. As a result, we continue to actively minimise opportunity for any harmful impacts of gambling while at the same time having the best possible impacts on the communities we fund.

Internationally New Zealand is one of the few countries without restrictions on the providers of online gambling. We do expect that the new government, will in time, exercise their political mandate and that this will influence the gambling environment across New Zealand. While the C4 sector in New Zealand is already heavily regulated and transparent it is currently an anomaly that the online gambling sector is unregulated. This is an area where we expect to see change in 2024.

In 2023 AGT welcomed two new area representatives, Steve Cleave (upper South Island) and Ciaran O'Kelly (lower North Island).



These appointments will allow us to expand our reach and improve our levels of customer service in these areas. At the same time, our on-going attention to fleet improvement and technologybased solutions to the business challenges we are all facing, underpins our determination and commitment to provide the best possible service to our Venues. The fact that AGT has continued to improve the average gaming machine income per week across 2023 is evidence that these initiatives are working.

The gambling regulators have been visiting venues recently to assess how staff have been implementing the new regulations. A number of AGT venues were visited. Overall, AGT venues were showing a good understanding of the new regulations, and a willingness to comply.

It is pleasing to report that grant recipient numbers increased from 1123 in 2022 to over 1160 in 2023 resulting in community groups across New Zealand receiving in excess of \$12.8 million an increase of approximately \$875,000 on 2022.

The Board of Trustees would like to express their gratitude to our venue operators for the work they do at the venue and within their local communities to ensure a safe entertainment experience for gambling customers. AGT, as a socially responsible operator, will continue to fund a broad base of organisations supporting local communities. We fund community groups, amateur sport, education, health, and the arts.

The Board would like to express its thanks to the staff for their work and continued support of AGT and its objectives throughout 2023.

AOTEAROA GAMING TRUST SUMMARY NOTES TO THE FINANCIAL STATEMENTS

1. Aotearoa Gaming Trust (the "Trust") is a charitable trust registered in New Zealand under the Charitable Trusts Act 1957. The Trust is involved in the gaming industry, and its principal trading activities are the ownership and operation of gaming machines, and the distribution of surpluses arising from these activities to community groups either within the region from which the surpluses originated, or to organisations which provide services nationally in accordance with the standards and practices set out by the Gambling Act 2003 and the associated regulations.

2. The full financial statements of the Trust have been prepared in accordance with Generally Accepted

Accounting Practice in New Zealand ('NZ GAAP'). They comply with PBE Standards as appropriate for Tier 2 not-forprofit public benefit entities. The functional and presentation currency for the Trust is New Zealand Dollars. Note that the 2023 period is 53 weeks and the 2022 comparative period is 52 weeks.

3. The summary financial statements have been extracted from the full financial statements. The financial statements of Aotearoa Gaming Trust include the Statement of Comprehensive Revenue and Expense, Statement of Financial Position, Statement of Changes in Equity and Statement of Cash Flows. The summary financial statements do not include all the disclosures contained in the full financial statements and cannot be expected to provide as complete an understanding as provided by the full financial statements.

4. A copy of the financial statements may be obtained on request from the Trust's office (Telephone 0800 424 274), PO Box 858, Dunedin.

5. The Trust maintains an interest register in which the Trustees record all parties and transactions which they have an interest. At the time of discussion and approval of the grants the relevant trustee noted their involvement and excluded themselves from the decision making process.
